SUBJECT: New Commercial Availability (Formerly "Short Supply") Review on
Apparel of Certain Corduroy Fabrics

The U.S. International Trade Commission has commenced a review to provide advice in connection with a petition filed under the "commercial availability" provisions of the Andean Trade Preference Drug Enforcement Act (ATPDEA) on apparel of certain corduroy fabrics. The fabric may be classified in the Harmonized Tariff Schedule of the United States (HTS) under subheading 5801.22.90.

This review is being conducted under the Commission's investigation for all such requests during 2003, investigation No. 332-450, *Commercial Availability of Apparel Inputs (2003): Effect of Providing Preferential Treatment to Apparel Imported from Sub-Saharan African, Caribbean Basin, and Andean Countries*, which was requested by the United States Trade Representative (USTR).

The Commission's review concerns a petition received by the Committee for the Implementation of Textile Agreements (CITA) on March 17, 2003, from The Breaker Jeanswear/ARC International of Miami, FL, alleging that the subject fabric cannot be supplied by the domestic industry in commercial quantities in a timely manner. The Commission will provide advice to the USTR concerning the probable economic effect on affected segments of the U.S. textile and apparel industries, workers in these industries, and consumers of granting duty-free and quota-free treatment to apparel made in eligible ATPDEA countries from the subject fabric should CITA determine that the fabric cannot be supplied by the domestic industry in commercial quantities in a timely manner. The Commission will submit its advice to the USTR in a classified report by April 28, 2003, and issue a public version of the report soon thereafter.

The Commission invites interested parties to submit written statements (original and 3 copies) concerning issues to be addressed by the Commission in this review, by April 15, 2003.
