SUBJECT: Commercial Availability Review on Women's & Children's Apparel of
Polyester Monofilament Yarn (Investigation No. 332-458-016)

The U.S. International Trade Commission initiated a review to provide advice concerning a petition filed under the "commercial availability" provision of the Andean Trade Promotion and Drug Eradication Act (ATPDEA) on women's and children's apparel of certain polyester monofilament yarn. The petition describes the yarn as a texturized, raw, white yarn of denier 20D/F1, classified in HTS subheading 5402.33.30. The petition was filed by Textiles Erre Emme Ltda. of Bogota, Colombia, and received by the Committee for the Implementation of Textile Agreements (CITA) on August 23, 2004. The petition alleges that the yarn cannot be supplied by the domestic industry in commercial quantities in a timely manner.

The Commission will provide probable economic effects advice in the review for the napped sheeting fabrics under its investigation No. 332-458, *Commercial Availability of Apparel Inputs (2004): Effect of Providing Preferential Treatment to Apparel Imported from Sub-Saharan African, Caribbean Basin, and Andean Countries*, instituted at the request of the United States Trade Representative (USTR). The advice concerns the probable economic effect on U.S. producers, workers, and consumers of granting duty-free and quota-free treatment to apparel made in eligible countries from the specified fabrics or yarns, regardless of the source of such inputs, should CITA determine that the fabrics or yarns cannot be supplied by the domestic industry in commercial quantities in a timely manner.

The Commission plans to submit its advice for this review in a classified report to USTR by October 4, 2004. The Commission will issue a public version of the review soon thereafter.
