With respect to Respondent Apple Inc., it is held that no violation of Section 337 of the Tariff Act of 1930, as amended (19 U.S.C. § 1337), has occurred in the importation into the United States, the sale for importation, or the sale within the United States after importation, of certain electronic devices, including mobile phones, portable music players, or computers by reason of infringement of one or more of claims 1, 10-13, 22 and 25 of United States Patent No. 6,518,957. (See JX-126.)

With respect to Respondent Apple Inc., it is held that no violation of Section 337 of the Tariff Act of 1930, as amended (19 U.S.C. § 1337), has occurred in the importation into the United States, the sale for importation, or the sale within the United States after importation, of certain electronic devices, including mobile phones, portable music players, or computers by reason of infringement of one or more of claims 1-12 of United States Patent No. 6,714,091.

With respect to Respondent Apple Inc., it is held that no violation of Section 337 of the Tariff Act of 1930, as amended (19 U.S.C. § 1337), has occurred in the importation into the United States, the sale for importation, or the sale within the United States after importation, of certain electronic devices, including mobile phones, portable music players, or computers by reason of infringement of one or more of claims 1-6 and 8 of United States Patent No. 6,834,181.

With respect to Respondent Apple Inc., it is held that no violation of Section 337 of the Tariff Act of 1930, as amended (19 U.S.C. § 1337), has occurred in the importation into the United States, the sale for importation, or the sale within the United States after importation, of

certain electronic devices, including mobile phones, portable music players, or computers by reason of infringement of one or more of claims 1 and 16 of United States Patent No. 6,895,256.

With respect to Respondent Apple Inc., it is held that no violation of Section 337 of the Tariff Act of 1930, as amended (19 U.S.C. § 1337), has occurred in the importation into the United States, the sale for importation, or the sale within the United States after importation, of certain electronic devices, including mobile phones, portable music players, or computers by reason of infringement of claim 5 of United States Patent No. 6,924,789.

It is further held that a domestic industry exists that practices U.S. Patent No. 6,924,789, and does not exist that practices U.S. Patent Nos. 6,714,091, 6,834,181, and 6,895,256.
