INTRODUCTION

This compilation summarizes information on the result or current status of determinations by the U.S. Tariff Commission under section 301 of the Trade Expansion Act of 1962.

The publication is divided into three sections. The first, with page numbers preceded by I -, gives information on investigations conducted pursuant to section 301(b) of the Act. These investigations are to determine whether, as a result in major part of concessions granted under trade agreements, an article is being imported into the United States in such increased quantities as to cause, or threaten to cause, serious injury to the domestic industry producing an article like or directly competitive with the imported article.

The second section, with page numbers preceded by F -, gives information on investigations conducted pursuant to section 301(c)(1) of the Act. These investigations are to determine whether, as a result in major part of concessions granted under trade agreements, an article like or directly competitive with an article produced by a firm is being imported into the United States in such increased quantities as to cause, or threaten to cause, serious injury to such firm.

The third section, with page numbers preceded by W -, gives information on investigations conducted pursuant to section 301(c)(2) of the Act. These investigations are to determine whether, as a result in major part of concessions granted under trade agreements, an article like or directly competitive with an article produced by the workers' firm, or an appropriate subdivision thereof, is being imported into the United States in such increased quantities as to cause, or threaten to cause, unemployment or underemployment of a significant number or proportion of the workers of such firm or subdivision.
