

"During {the 2013} crop cycle, imports from Mexico flooded into the U.S. market over two million tons at very depressed price levels. ... Refined prices from Mexico were so low that we were not able to achieve a margin that would cover variable costs, even at raw sugar prices that were at USDA loan rates. ... We didn't feel the full economic impact of these low prices during the fiscal 2013 crop cycle, due to the way large customers forward-cover their business. The full impact is being felt now, and will persist well into the 2015 cycle, and also into the 2016 cycle as well."

"I hope the government-to-government effort succeeds in curing continuing injury far into the future, but it will do nothing about the present injury and it will do nothing about the injury that has already been locked into contracts for future delivery.
