Product information, including uses/applications and source(s) of imports:

The synthetic organic chemical, 3-cyclohexene-1-carboxylic acid, 6-[(di-2-propenylamino)carbonyl]-, (1R,6R)-rel-, reaction product with pentafluoroiodoethane-tetrafluoroethylene telomer, ammonium salt, is used in the manufacture of specialty paper products to impart certain oil- and grease-resistant properties to the finished paper/paperboard product. Ciba Specialty Chemicals imports the subject chemicals from its affiliated plant in Germany.
