Nature of bill: Temporary duty suspension through December 31, 2008.

Suggested article description(s) for enactment (including appropriate HTS subheading(s)):

Mixtures of 2,6-Dibromo-4-cyanophenyl octanoate/heptanoate and 2-ethylhexyl (4-chloro-2-methylphenoxy)acetate (CAS Nos.1689-99-2, 56634-95-8, and 29450-45-1) (provided for in subheading 3808.30.15).

Product information, including uses/applications and source(s) of imports:

The product, a mixture of certain synthetic organic chemicals, 2,6-dibromo-4-cyanophenyl octanoate/heptanoate and 2-ethylhexyl (4-chloro-2-methyl phenoxy)acetate, is used as a contact and postemergence herbicide to control a number of annual broadleaf weeds in certain crop plantings such as cereals, field corn, forage grasses, and turf . Currently, there is no U.S. production of this product. This product is imported from the United Kingdom as the mixture and then formulated and packaged for sale.

There are other herbicides that compete with this product in certain crop areas such as cereals and turf.

2/ In a telephone conversation with Mr. Gill, representative of Bayer CropScience on July 7, 2005, Mr. Gill indicated that Bayer was seeking a temporary duty reduction to 2.9%. In the event of a temporary duty reduction to 2.9%, the Customs revenue loss would be \$491,760 per year.

Technical comments:³

The Commission suggests that the article description on page 1 of this report be used in order to reflect that the product is a mixture.

As previously mentioned, a representative for the proponent told the Commission that the firm is seeking a temporary duty reduction to 2.9% from the current duty rate of 6.5%. If the intent is a temporary duty reduction to 2.9% rather than a temporary duty suspension, then the Commission suggests that the word “Free” in the proposed new heading be changed to “2.9%”.

³ The Commission may express an opinion on the HTS classification of a product to facilitate consideration of the bill. However, by law, only the U.S. Customs Service is authorized to issue a binding ruling on this matter. The Commission believes that the U.S. Customs Service should be consulted prior to enactment of the bill.
