Nature of bill: Extension of temporary duty suspension through December 31, 2008.

Suggested article description(s) for enactment (including appropriate HTS subheading(s)):

2-Pyrimidinamine, 4-cyclopropyl-6-methyl-N-phenyl-(Cyprodinil) (CAS No. 121552-61-2) (provided for in subheading 2933.59.15)

Product information, including uses/applications and source(s) of imports:

The subject chemical, known as Cyprodinil, is a synthetic organic chemical used in the manufacture of fungicides used to control blight, scab and botrytis in apples, grapes, almonds and stone fruit. Cyprodinil fungicides are niche products. One niche is in combination with fludioxinil as the best performing product for botrytis in strawberries. The combination provides two modes of action and is potentially useful for fungicide resistance management. Cyprodinil is imported from Switzerland.

A BILL

To extend the duty suspension on cyprodinil.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. CYPRODINIL.**

4 (a) IN GENERAL.—Heading 9902.02.08 of the Har-
5 monized Tariff Schedule of the United States (relating to
6 cyprodinil) is amended by striking “12/31/2006” and in-
7 serting “12/31/2008”.

8 (b) EFFECTIVE DATE.—The amendment made by
9 subsection (a) applies to goods entered, or withdrawn from
10 warehouse for consumption, on or after the 15th day after
11 the date of the enactment of this Act.
