Aniline-2,5-disulfonic acid is a synthetic organic chemical used as an intermediate in the manufacture of paper finishing chemicals and dyes. Clariant imports this chemical from China and India.

The Commission suggests that the article description on page 1 of this report be used in the proposed new heading in order to change the period in the chemical name to a comma, and to provide the correct HTS subheading.

³ The Commission may express an opinion on the HTS classification of a product to facilitate consideration of the bill. However, by law, only the U.S. Customs Service is authorized to issue a binding ruling on this matter. The Commission believes that the U.S. Customs Service should be consulted prior to enactment of the bill.

3 **SECTION 1. ANILINE 2.5 DI-SULPHONIC ACID.**

4 (a) IN GENERAL.—Subchapter II of chapter 99 of
5 the Harmonized Tariff Schedule of the United States is
6 amended by inserting in numerical sequence the following
7 new heading:
