**Nature of bill:** Temporary duty suspension through December 31, 2008.

2-(Isocyanatosulfonyl)benzoic acid, methyl ester (CAS No. 74222-95-0) (provided for in subheading 2930.90.29)

**Product information, including uses/applications and source(s) of imports:**

The subject product is a synthetic organic chemical intermediate used to produce several sulfonylurea herbicides. These herbicides are further formulated into a variety of postemergence end use herbicide products used for selective grass and weed control in the U.S. cereals markets. The product is imported from China, though it may also be imported from India in the future.

To suspend temporarily the duty on CMBSI.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. CMBSI.**

4 (a) IN GENERAL.—Subchapter II of chapter 99 of  
5 the Harmonized Tariff Schedule of the United States is  
6 amended by inserting in numerical sequence the following  
7 new heading:

“	9902.09.03	2-(isocyanatosulfonyl)-benzoic acid, methyl ester (CMBSI) (CAS No. 64900-65-8) (provided for in sub-heading 2930.90.29) .....	Free	No change	No change	On or before 12/31/2008	”.

8 (b) EFFECTIVE DATE.—The amendment made by
