
Product information, including uses/applications and source(s) of imports:

The product is a synthetic organic chemical used as both a pre- and post-emergence herbicide to control selected weeds on soybeans, corn, and certain vegetables and for non-selective weed control on non-cropland areas. The product is imported from Israel, Italy, and Germany.

5 the Harmonized Tariff Schedule of the United States is
6 amended by inserting in numerical sequence the following
7 new heading:
