2,6-Dichloroaniline (CAS No. 608-31-1) (provided for in subheading 2921.42.90).

Product information, including uses/applications and source(s) of imports:

The subject product is a synthetic organic chemical that is used as a raw material in the formulation of Diclosulam® and Strong Arm® fungicides that are used on crops such as soybeans, peanuts, and sugarcane. The product is imported from China.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. 2,6-DICHLOROANILINE.**

4 (a) IN GENERAL.—Heading 9902.29.17 of the Har-
5 monized Tariff Schedule of the United States (relating to
6 2,6-Dichloroaniline) is amended by striking “12/31/2009”
7 and inserting “12/31/2011”.

8 (b) EFFECTIVE DATE.—The amendment made by
9 subsection (a) applies to goods entered, or withdrawn from

- 1 warehouse for consumption, on or after the 15th day after
- 2 the date of the enactment of this Act.
