Propanoic acid, 3-hydroxy-2-(hydroxymethyl)-2-, methyl polymers with 5-isocyanato-1-(isocyanatomethyl)-1,3,3-trimethylcyclohexane and reduced methyl esters of reduced polymerized, oxidized tetrafluoroethylene, compounds with trimethylamine (CAS No. 328389-91-9) (provided for in subheading 3904.69.50).

**Product information, including uses/applications and source(s) of imports:**

The subject product is a synthetic organic chemical that is used as an oil and water repellent in the manufacture of food-contact paper and paperboard. Solvay Solexis imports the subject chemical from Italy.

1 **SECTION 1. PROPANOIC ACID, 3-HYDROXY-2-(HYDROXY-**  
 2 **METHYL)-2-METHYL-, POLYMERS WITH 5-ISO-**  
 3 **CYANATO-1-(ISOCYANATOMETHYL)-1,3,3-TRI-**  
 4 **METHYLCYCLOHEXANE AND REDUCED METH-**  
 5 **YL ESTERS OF REDUCED POLYMERIZED,**  
 6 **OXIDIZED TETRAFLUOROETHYLENE, COM-**  
 7 **POUNDS WITH TRIMETHYLAMINE.**

8 (a) IN GENERAL.—Subchapter II of chapter 99 of  
 9 the Harmonized Tariff Schedule of the United States is  
 10 amended by inserting in numerical sequence the following  
 11 new heading:
