Mixtures containing n-butyl-1,2-benzisothiazolin-3-one (Butyl benzisothiazoline) (CAS No. 4299-07-4), 1-hydroxypyridine-2-thione, zinc salt (Zinc pyrithione) (CAS No. 13463-41-7) and application adjuvants (provided for in subheading 3808.99.08).

Product information, including uses/applications and source(s) of imports:

The subject product is effective against fungi and bacteria, and is used in the protection of plastic products that are made from polymers such as polyvinylchloride, polyurethanes, and other plastics. The product is imported from Great Britain.

However, by law, only the U.S. Customs Service is authorized to issue a binding ruling on this matter. The Commission believes that the U.S. Customs Service should be consulted prior to enactment of the bill.
