**MEMORANDUM ON PROPOSED TARIFF LEGISLATION
of the 110th Congress¹**

[Date approved: July 1, 2008]²

Bill No. and sponsor: H.R. 5097 (Mr. Howard Coble of North Carolina).

Proponent name,³ location: National Council of Textile Organizations, Washington DC.

Other bills on product (110th Congress only): None.

Nature of bill: Extension of temporary duty suspension through December 31, 2011.

Retroactive effect: None.

Suggested article description(s) for enactment (including appropriate HTS subheading(s)):

Staple fibers of rayon, carded, combed, or otherwise processed for spinning (provided for in subheading 5507.00.00).

Check one: Same as that in bill as introduced.
 Different from that in bill as introduced (see Technical comments section).

Product information, including uses/applications and source(s) of imports:

Rayon is an artificial fiber produced from cellulosic materials such as wood pulp, which is dissolved into a viscose solution and extruded through perforated metal disks (spinnerets) into an acid bath to produce long fiber strands. The rayon strands are then cut to produce staple fibers. U.S. imports of all carded, combed, or processed artificial staple fibers (a broader product scope than is covered by the duty suspension) under HTS heading 5507.00.00 totaled \$1.03 million in 2007, of which dutiable imports amounted to about \$477,000. Austria, Italy, China, and Germany were the primary suppliers of goods classified in this heading; Austria appears to be the leading source of goods imported without payment of duty.

A BILL

To extend the temporary suspension of duty on certain staple fibers of viscose rayon, carded, combed, or otherwise processed for spinning.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. CERTAIN STAPLE FIBERS OF VISCOSE RAYON,**
4 **CARDED, COMBED, OR OTHERWISE PROC-**
5 **ESSED FOR SPINNING.**

6 (a) IN GENERAL.—Heading 9902.23.34 of the Har-
7 monized Tariff Schedule of the United States (relating to
8 certain staple fibers of viscose rayon, carded, combed, or
9 otherwise processed for spinning) is amended by striking
10 “12/31/2009” and inserting “12/31/2011”.

1 (b) EFFECTIVE DATE.—The amendment made by
2 subsection (a) applies to goods entered, or withdrawn from
3 warehouse for consumption, on or after the 15th day after
4 the date of the enactment of this Act.
