**Bill No. and sponsor:** H.R. 5334 (Mr. David E. Price of North Carolina).

**Proponent name,<sup>3</sup> location:** Bayer CropScience, Research Triangle Park, NC.

**Nature of bill:** Temporary duty suspension through December 31, 2011.

**Retroactive effect:** None.

**Suggested article description(s) for enactment (including appropriate HTS subheading(s)):**

Mixtures containing methyl 2-[(4,6-dimethoxypyrimidin-2-yl)carbamoyl]sulfamoyl]- $\alpha$ -(methanesulfonamido)-*p*-toluate (Mesosulfuron-methyl) (CAS No. 208465-21-8) and methyl 4-iodo-2-[3-(4-methoxy-6-methyl-1,3,5-triazin-2-yl)ureidosulfonyl]benzoate, sodium salt (Iodosulfuron methyl, sodium salt) (CAS No. 144550-36-7), whether or not mixed with application adjuvants (provided for in subheading 3808.93.15).

**Product information, including uses/applications and source(s) of imports:**

The subject mixture of synthetic organic chemicals is a post-emergent herbicide product for controlling annual ryegrass (or Italian ryegrass), wild oats, and other broadleaf weeds. The product is imported from Germany.

8 (a) IN GENERAL.—Subchapter II of chapter 99 of
