**MEMORANDUM ON PROPOSED TARIFF LEGISLATION
of the 110th Congress¹**

[Date approved: July 22, 2008]²

Bill No. and sponsor: H.R. 5399 (Mr. Darrell Issa of California).

Proponent name,³ location: Outdoor Industry Association, Boulder, CO.

Other bills on product (110th Congress only): H.R. 5553.

Nature of bill: Temporary duty suspension through December 31, 2011.

Retroactive effect: None.

Suggested article description(s) for enactment (including appropriate HTS subheading(s)):

Travel bags of manmade fibers, with outer surface of textile materials, the foregoing valued over \$30 each, not exceeding 80 liters in interior volume and with wheels, a telescoping handle, stowable shoulder straps and a removable separate backpack or daypack attached by zipper or other means, such backpack or daypack not exceeding 26 liters in interior volume (provided for in subheading 4202.12.80).

Product information, including uses/applications and source(s) of imports:

The subject product is travel luggage made of woven textile fabrics of man-made fibers and is valued over \$30 each. It comprises two joined pieces: (1) a travel bag with wheels, a telescoping handle and stowable shoulder straps and measuring not over 4,900 cubic inches (80 liters) in interior volume, and (2) a removable separate backpack or daypack affixed by zipper or other means, measuring not over 1,600 cubic inches (26 liters) in interior volume. The subject product is designed primarily for airline travel and for "adventure travel." The bulk of the subject products are imported from China, followed by Vietnam, Thailand, the Philippines, and Italy. Dutiable U.S. imports under HTS subheading 4202.12.80 (a broader category than is covered by this bill) totaled \$592.5 million in 2007, of which China accounted for \$529.4 million in shipments.

3 **SECTION 1. CERTAIN TRAVEL BAGS WITH A REMOVABLE**

4 **BACKPACK OR DAYPACK.**

5 (a) IN GENERAL.—Subchapter II of chapter 99 of
6 the Harmonized Tariff Schedule of the United States is
7 amended by inserting in numerical sequence the following
8 new heading:

“	9902.01.00	Travel bags of manmade fibers, with wheels, a telescoping handle, stowable shoulder straps, and a removable separate backpack or daypack attached by zipper or other means, valued over \$30, not to exceed 4,900 cubic inches (80 liters) in volume, and removable separate backpack or daypack not to exceed 1,600 cubic inches (26 liters) in volume (provided for in subheading 4202.12.80) ...
