The subject product is used as an intermediate in the production of several chemicals, including certain pigments, an epoxy curing agent, and white grease. The product is imported from Germany.

3 **SECTION 1. P-TOLUIDINE.**

4 (a) IN GENERAL.—Subchapter II of chapter 99 of
5 the Harmonized Tariff Schedule of the United States is
6 amended by inserting in numerical sequence the following
7 new heading:

8 (b) EFFECTIVE DATE.—The amendment made by
