**Nature of bill:** Extension of temporary duty suspension through December 31, 2011.<sup>4</sup>

N,N'-Hexane-1,6-diylbis(3-(3,5-di-tert-butyl-4-hydroxyphenylpropionamide)) (CAS No. 23128-74-7)

**Product information, including uses/applications and source(s) of imports:**

This synthetic organic chemical is used as an antioxidant to improve color retention in plastics articles and polyamide fibers. The product is imported from Germany and Switzerland.

## A BILL

To extend the temporary suspension of duty on N,N-hexane-1,6-diylbis(3-(3,5-di-tert-butyl-4-hydroxy-phenylpropionamide)).

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. N,N-HEXANE-1,6-DIYLBIS(3-(3,5-DI-TERT-BUTYL-**  
4 **4-HYDROXY-PHENYLPROPIONAMIDE)).**

5 (a) IN GENERAL.—Heading 9902.24.23 of the Har-  
6 monized Tariff Schedule of the United States (relating to  
7 N,N-hexane-1,6-diylbis(3-(3,5-di-tert-butyl-4-hydroxy-  
8 phenylpropionamide))) is amended by striking “12/31/  
9 2009” and inserting “12/31/2011”.

1       (b) **EFFECTIVE DATE.**—The amendment made by  
2 subsection (a) applies to goods entered, or withdrawn from  
3 warehouse for consumption, on or after the 15th day after  
4 the date of the enactment of this Act.
