Pigment violet 23 in an acrylic dispersion (CAS No. 6358-30-1) (provided for in subheading 3204.17.90).

Product information, including uses/applications and source(s) of imports:

The subject product is a surface active agent that modifies dispersion viscosities. The product is imported from Japan.⁴

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. CARBAZOLE VIOLET/ACRYLIC DISPERSION.**

4 (a) IN GENERAL.—Subchapter II of chapter 99 of
5 the Harmonized Tariff Schedule of the United States is
6 amended by inserting in numerical sequence the following
7 new heading:
