**MEMORANDUM ON PROPOSED TARIFF LEGISLATION
of the 111th Congress ¹**

Bill No. and sponsor: S. 2301 (Mr. Sherrod Brown of Ohio et al.).

Proponent name,³ location: Perstorp Polyols, Inc., Toledo, OH.

Nature of bill: Temporary duty suspension through December 31, 2011.

Retroactive effect: None.

Suggested article description(s) for enactment (including appropriate HTS subheading(s)):

Propanoic acid, 3-hydroxy-2-(hydroxymethyl)-2-methyl-homopolymer, ester with α -hydro- ω -hydroxypoly(oxy-1,2-ethanediyl) ether with 2,2-bis(hydroxymethyl)-1,3-propanediol (4:4:1), 2,2-bis[(2-propenyloxy)methyl]butylsuccinates C3-24 carboxylates (CAS No. 462113-23-1) (provided for in subheading 3907.50.00).

Product information, including uses/applications and source(s) of imports:

The subject product is a low viscosity clear to dark amber liquid fatty acid modified dendritic (highly branched) polymer with a large number of polyunsaturations. This experimental polymer is used in various binders, paints, and as an air drying resin for paints and coatings. It is commonly used as a component in low-volatile organic compound liquid coating compositions for wood. The subject product is imported from Germany.

The Commission staff suggests that the article description on page 1 of this report be used in the proposed new heading in order to add the abbreviation “No.” after “CAS” in the article description and to delete the comma where it appears after “-2-methyl-” in the bill.

⁴ The Commission may express an opinion on the HTS classification of a product to facilitate consideration of the bill. However, by law, only the U.S. Customs Service is authorized to issue a binding ruling on this matter. The Commission believes that the U.S. Customs Service should be consulted prior to enactment of the bill.
