**Proponent name,<sup>3</sup> location:** Rhein Chemie Corporation, Chardon, OH.

**Nature of bill:** Extension of temporary duty suspension through December 31, 2011.<sup>4</sup>

**Retroactive effect:** None.

**Suggested article description(s) for enactment (including appropriate HTS subheading(s)):**

Mixtures of zinc dicyanato diamine (CAS No. 122012-52-6) with an elastomer binder of ethylene-propylene-diene monomer and ethyl vinyl acetate, and dispersing agents (provided for in subheading 3812.10.50).

**Product information, including uses/applications and source(s) of imports:**

The subject product is a synthetic organic chemical that is used as a crosslinking agent for rubber, particularly in the production of transportation-related and technical rubber goods. Some of the final compounds are used to make hoses, belts, vibration control rubber parts, and automotive weather seals. The product is imported from Germany.

## A BILL

To extend temporarily the suspension of duty on Rhenogran  
Geniplex-70.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. RHENOGRAN GENIPILEX-70.**

4 (a) IN GENERAL.—Heading 9902.12.76 of the Har-  
5 monized Tariff Schedule of the United States (relating to  
6 Rhenogran Geniplex-70) is amended by striking the date  
7 in the effective column period and inserting “12/31/2011”.

8 (b) EFFECTIVE DATE.—The amendment made by  
9 subsection (a) applies to goods entered, or withdrawn from

- 1 warehouse for consumption, on or after the 15th day after
- 2 the date of the enactment of this Act.
