**Nature of bill:** Extension of temporary duty suspension through December 31, 2011.<sup>4</sup>

4,8-Dicyclohexyl -6-2,10-dimethyl -12*H*-dibenzo[*d,g*][1,3,2]- dioxaphosphocin (CAS No. 73912-21-7)

**Product information, including uses/applications and source(s) of imports:**

The subject product is a synthetic organic chemical that is used in the stabilization of acrylonitrile-butadiene-styrene (thermoplastic) copolymers. The product is used in automotive parts, dishwashers, and liners for refrigerators and freezers. The product is imported from Germany.

## A BILL

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. THERMOSTABILIZER KL3–2049.**

4 (a) IN GENERAL.—Heading 9902.12.77 of the Har-  
5 monized Tariff Schedule of the United States (relating to  
6 Thermostabilizer KL3–2049) is amended by striking the  
7 date in the effective column period and inserting “12/31/  
8 2011”.

9 (b) EFFECTIVE DATE.—The amendment made by  
10 subsection (a) applies to goods entered, or withdrawn from

- 1 warehouse for consumption, on or after the 15th day after
- 2 the date of the enactment of this Act.
