The subject product is a synthetic organic chemical that is used as a raw material in the production of aviation hydraulic fluid. The product is imported from Italy.

3 **SECTION 1. POTASSIUM DECAFLUORO(PENTAFLUORO-**
4 **ETHYL)CYCLOHEXANESULFONATE.**

5 (a) IN GENERAL.—Subchapter II of chapter 99 of
6 the Harmonized Tariff Schedule of the United States is
7 amended by inserting in numerical sequence the following
8 new heading:
