**MEMORANDUM ON PROPOSED TARIFF LEGISLATION
of the 111th Congress¹**

[Date approved: April 23, 2010]²

Bill No. and sponsor: S. 2611 (Mr. Charles E. Schumer of New York).

Proponent name,³ location: Nikon Corp., Mellville, NY.

Other bills on product (111th Congress only): None.

Nature of bill: Temporary duty suspension through December 31, 2011.

Retroactive effect: None.

Suggested article description(s) for enactment (including appropriate HTS subheading(s)):

Lenses designed for digital cameras, the foregoing with a focal length measuring approximately 55 mm or more but not over 200 mm and weighing between 329 grams to 339 grams (provided for in subheading 9002.11.90).

Product information, including uses/applications and source(s) of imports:

The subject lenses are optical camera lenses optimized for use with digital single lens reflex (DSLR) cameras, which can accept a variety of interchangeable lenses with differing lengths, widths, weights, or other characteristics to enable the user to perform different photographic functions. The subject lenses are normally referred to as wide angle lenses, which permit the user to enlarge the image by bringing it in closer (zooming in) or to minimize the image by moving out farther (zooming out), and to frame the image as desired by extending or retracting the focal length of the lens. The subject lenses enable the user to extend the focal length of the lens, expressed in terms of equivalent focal lengths of traditional optical single lens reflex (SLR) cameras, up to a maximum of 200 mm and reduce the focal length to as low as 55 mm. Other lenses of this type may allow reduction of the focal length to as low as 10 mm. These capabilities provide flexibility to meet various demands of the user in framing the desired picture.

The subject lenses are imported primarily from Japan and China.

Technical comments:⁴

We note only that, should a lens weigh exactly 329 or 339 grams, Customs might read the provision as not covering it, given the wording of the standard as “between” those two weights. Whether this might have an impact with respect to the proponent’s imports is not known.

⁴ The Commission may express an opinion on the HTS classification of a product to facilitate consideration of the bill. However, by law, only the U.S. Customs Service is authorized to issue a binding ruling on this matter. The Commission believes that the U.S. Customs Service should be consulted prior to enactment of the bill.
