The Commission staff suggests that, in section 1(a) of the bill, line 5, the phrase “Headings 2933.69.60 and” be deleted and that the word “Heading” be inserted in lieu thereof.

⁵ The Commission may express an opinion on the HTS classification of a product to facilitate consideration of the bill. However, by law, only the U.S. Customs Service is authorized to issue a binding ruling on this matter. The Commission believes that the U.S. Customs Service should be consulted prior to enactment of the bill.
