Preformed iodide pellets or powder composed of iodides of dysprosium, thallium, sodium, holmium, thulium, and calcium (CAS Nos. 7681-82-5, 7790-30-9, 15474-63-2, 13813-41-7, 13813-43-9, and 10102-68-8) (provided for in subheading 2827.60.51)

**III. Other product information, including uses/applications and source(s) of imports**

The subject product is used to improve the color rendition and appearance of lighting in ceramic discharge metal halide lamps. It is imported from Belgium.

Preformed iodide pellets were covered by HTS heading 9902.25.12, which expired on December 31, 2009. This Chapter 99 provision did not cover iodide powder as the current bill does.

## A BILL

To suspend temporarily the duty on preformed iodide pellets or powder composed of iodides of dysprosium, thallium sodium, holmium, thulium and calcium.

1 *Be it enacted by the Senate and House of Representa-*

3 **SECTION 1. PREFORMED IODIDE PELLETS OR POWDER**  
4 **COMPOSED OF IODIDES OF DYSPROSIUM,**  
5 **THALLIUM SODIUM, HOLMIUM, THULIUM**  
6 **AND CALCIUM.**

7 (a) IN GENERAL.—Subchapter II of chapter 99 of  
8 the Harmonized Tariff Schedule of the United States is

1 amended by inserting in numerical sequence the following  
 2 new heading:
