**II. Suggested article description(s) for enactment (including appropriate HTS subheading(s)):**

Book-style covers with an outer surface of plastics, designed for use with portable electronic devices of a kind classified in heading 8470, 8471, 8543 or 8517 (provided for in subheading 3926.10.00)

(If enacted, the tariff relief provided for in this bill would be available to any entity that imports the product that is covered by the bill.)

**III. Other product information, including uses/applications and source(s) of imports**

The subject products are soft, plastic book-style covers designed to house and protect a large variety of portable electronic devices such as electronic readers and tablets. As such, they are designed to fold around the electronic device like a book's protective cover and make the devices more comfortable to hold. These products are mainly imported from China, Taiwan, and Korea. Several binding rulings from U.S. Customs and Border Protection cover these products: N056187, April 23, 2009; N150305, March 25, 2011; and N185835, October 21, 2011.

3 **SECTION 1. CERTAIN PLASTIC DEVICE BOOK STYLE COV-**  
4 **ERS.**

5 (a) IN GENERAL.—Subchapter II of chapter 99 of  
6 the Harmonized Tariff Schedule of the United States is  
7 amended by inserting in numerical sequence the following  
8 new heading:

1           (b) **EFFECTIVE DATE.**—The amendment made by
