**Nature of bill:** Extension of temporary duty suspension through December 31, 2011.

2-Ethylhexyl (4-chloro-2-methylphenoxy)acetate (CAS No. 29450-45-1) (provided for in subheading 2918.99.20).

**Product information, including uses/applications and source(s) of imports:**

The subject product is a synthetic organic chemical that is used as a postemergence selective herbicide to control specific annual and perennial broadleaf weeds. It is used as a translocated herbicide on peas, cereals, grasslands, tree crops, and turf. The product is imported from the United Kingdom as a technical material and then formulated and packaged for sale.

## A BILL

To extend the temporary suspension of duty on MCPA ester.

1       *Be it enacted by the Senate and House of Representa-*  
2       *tives of the United States of America in Congress assembled,*

3       **SECTION 1. MCPA ESTER.**

4       (a) IN GENERAL.—Heading 9902.10.54 of the Har-  
5       monized Tariff Schedule of the United States is amended  
6       by striking “12/31/2009” and inserting “12/31/2011”.

7       (b) EFFECTIVE DATE.—The amendment made by  
8       subsection (a) applies with respect to goods entered, or  
9       withdrawn from warehouse for consumption, on or after  
10      the 15th day after the date of the enactment of this Act.
