*O,O*-Diethyl phosphorochloridothioate (CAS No. 2524-04-1) (provided for in subheading 2920.19.50).

**Product information, including uses/applications and source(s) of imports:**

The subject product is a synthetic organic chemical that is used as an intermediate in the manufacture of Chlorpyrifos, the active ingredient in Lorsban® and Dursban® insecticidal formulations that are used on corn, wheat, citrus, stone fruit, and vegetable crops. The product is imported from Denmark.

## A BILL

To extend the temporary suspension of duty on DEPCT.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. DEPCT.**

4 (a) IN GENERAL.—Heading 9902.29.58 of the Har-  
5 monized Tariff Schedule of the United States (relating to  
6 *O,O*-Diethyl phosphorochlorodithioate) is amended by  
7 striking “12/31/2009” and inserting “12/31/2011”.

8 (b) EFFECTIVE DATE.—The amendment made by  
9 subsection (a) applies to goods entered, or withdrawn from  
10 warehouse for consumption, on or after the 15th day after  
11 the date of the enactment of this Act.
