The subject synthetic organic chemical is the active ingredient in the herbicide Strada®, which is used on rice and other crops to control weeds. It is imported from Italy.

6 (a) IN GENERAL.—Subchapter II of chapter 99 of  
7 the Harmonized Tariff Schedule of the United States is  
8 amended by inserting in numerical sequence the following  
9 new heading:
