However, by law, only the U.S. Customs Service is authorized to issue a binding ruling on this matter. 9 O,O-dimethyl phosphorodithioate is amended by striking
10 “12/31/2009” and by inserting “12/31/2011”.

1 (b) EFFECTIVE DATE.—The amendment made by
2 subsection (a) applies to goods entered, or withdrawn from
3 warehouse for consumption, on or after the 15th day after
4 the date of the enactment of this Act.
