The Commission staff recommends that the article description on page 1 of this report be used in the proposed new heading in order to present the CAS number with the chemical name and to include the common chemical name in parentheses.

⁴ The Commission may express an opinion on the HTS classification of a product to facilitate consideration of the bill. However, by law, only the U.S. Customs Service is authorized to issue a binding ruling on this matter. The Commission believes that the U.S. Customs Service should be consulted prior to enactment of the bill.
