Justification for Limited Competition
Justification and Approval (J&A) for Requisition 6100-OCIO-19-0014

The Office of Chief Information Officer (OCIO) previously procured Riverbed equipment and services to obtain a turnkey solution to purchase, configure, install, test, and provide knowledge transfer/training for WAN acceleration and caching.

The original work was done by Riverbed personnel who have knowledge of USITC's configuration. Riverbed personnel will have complete access to all required resources to make the necessary changes as quickly, efficiently and completely as is possible. In addition, Riverbed personnel have access to internal Riverbed engineering resources to expedite a resolution to any technical challenge that may arise during their time on-site

We are requiring that the response provide on-site personnel who can be easily verified as having the technical skills and product knowledge necessary to accurately and completely accomplish the tasks outlined above. The Riverbed Certified Performance Engineering (RCPE) program and certification process accomplishes this via a rigorous training and testing process to achieve RCPE certification. At a minimum we are requiring the response include a certified RCPE Professional in WAN optimization. This will ensure that the provided on-site resource has the knowledge, skills, and abilities to complete the work outlined in a timely and accurate manner.

It is because of these reasons, getting these services from RCPE Certified personnel is in the best interest of the Commission.
