

USITC PUBLISHES EIGHTH QUARTERLY REPORT
ON CERTAIN STATISTICS FOR
NONRUBBER FOOTWEAR

The United States International Trade Commission has completed its eighth quarterly statistical report on nonrubber footwear pursuant to Presidential Proclamation No. 4510 in connection with the orderly marketing agreements (OMA's) between the United States and Taiwan and the Republic of Korea. The report, covering 1977, 1978, and the first quarter of 1979, provides information on U.S. production, imports for consumption, apparent domestic consumption, employment, and wholesale and consumer price indexes.

According to the USITC report, domestic production of nonrubber footwear for the first quarter of 1979 was 100.9 million pairs, representing a decline of 4 percent over production in the corresponding period of 1978. U.S. consumption of nonrubber footwear in January-March 1979--211.2 million pairs--was 2 percent greater than that in January-March 1978.

Import penetration reached an alltime high in the first quarter of 1979 at 52 percent. First quarter 1979 imports of nonrubber footwear amounted to 109.8 million pairs, or 9 percent more than in the corresponding period of 1978. First quarter 1979 imports (35.6 million pairs) from the controlled countries--Taiwan and Korea--were 10.5 million pairs or 23 percent less than in the corresponding period of last year.

However, imports from the uncontrolled countries increased to 74.2 million pairs, 19.2 million pairs or 35 percent more than in the first quarter of 1978. Imports from Italy, Brazil, the Philippines, Hong Kong and Singapore showed significant rises.

The unemployment rate of domestic shoe workers reached an all-time high of 12.2 percent in the first quarter of 1979. The Wholesale Price Index for footwear rose to 203.7 in the first quarter of this year, compared with 175.4 a year ago.

The report is sent to the Special Representative for Trade Negotiations, who is responsible for monitoring the OMA's implemented by the Presidential proclamation.

Summary Highlights of Economic Conditions in the Nonrubber Footwear Industry in the First Calendar Quarter of 1979

U.S. production.--Domestic production of nonrubber footwear was 100.9 million pairs in January-March 1979, or 4 percent lower than that in January-March 1978 and 3 percent lower than that in January-March 1977 (table 1).

U.S. imports.--Nonrubber footwear imports amounted to 109.8 million pairs in January-March 1979, or 9 percent more than in the corresponding period of 1978 (table 5) and 8.9 million pairs greater than domestic production in January-March 1979 (table 1).

Ratio of imports to consumption.--The ratio of imports to consumption reached 52 percent in the first quarter of 1979, the highest quarterly import penetration ratio ever recorded. The previous high was 50 percent (table 1).

Source of imports.--The trend of declining nonrubber footwear imports from the controlled countries--Taiwan and the Republic of Korea--and increasing imports from the uncontrolled countries continued in the first quarter of 1979 (table 5). Imports from Taiwan and Korea declined 23 percent to 35.6 million pairs in that period from 46.1 million pairs in the first quarter of 1978. Imports from the uncontrolled countries increased from 55.0 million pairs during the first quarter of 1978 to 74.2 million pairs in the first quarter of 1979, or by 35 percent. The largest share of this increase was accounted for by Italy, whose shipments to the United States increased from 16.3 million pairs in the first quarter of 1978 to 27.9 million pairs in the corresponding period of 1979. The Philippines, Brazil, Singapore, and Hong Kong also significantly increased their nonrubber footwear shipments to the United States during this period.

Overall, the uncontrolled countries increased their share of the U.S. market from 39 percent in January-March 1977 to 61 percent in January-March 1979.

Average unit values.--Average unit values of imports from Taiwan and the Republic of Korea continued to rise rapidly, increasing 35 percent from \$2.89 in the first quarter of 1978 to \$3.89 in the first quarter of 1979 (table 7). Unit values for the uncontrolled countries were approximately \$6.00 in the first quarters of 1978 and 1979.

Prices.--The Wholesale Price Index for footwear increased to 203.7 in January-March 1979 from 175.4 in the corresponding period of 1978 (table 3). The monthly WPI increased at a sharply higher rate during the first quarter of 1979 than during the first quarter of 1978. The Consumer Price Index for footwear increased from 159.6 in the first quarter of 1978 to 169.7 in the first quarter of 1979.

Employment and unemployment rate.--Employment in the shoe industry reached an alltime low of 147,600 employees in February 1979, representing a drop of 8,400 employees from February 1978, and a drop of 17,000 employees from 1976 levels (tables 2 and 4). The unemployment rate 1/ for the first quarter of 1979 jumped to 12.2 percent, compared with 9.6 percent in the corresponding period last year and 7.7 percent in the last quarter of 1978 (table 3).










for consumption, by quarters, 1977-1979





1/ Unit value of U.S. shipments represents f.o.b. factory price less discounts and actual returns.




