USITC PUBLISHES NINTH QUARTERLY REPORT ON CERTAIN STATISTICS FOR NONRUBBER FOOTWEAR

The United States International Trade Commission has completed its ninth quarterly statistical report on nonrubber footwear pursuant to Presidential Proclamation No. 4510 in connection with the orderly marketing agreements (OMA's) between the United States and Taiwan and the Republic of Korea. The report, covering 1977, 1978, and the first and second quarters of 1979, provides information on U.S. production, exports, imports for consumption, apparent domestic consumption, employment, and producers' and consumer price indexes.

The report shows that domestic production of nonrubber footwear for the second quarter of 1979 was 99.0 million pairs, a decline of 12 percent from that in the corresponding period of 1978. U.S. consumption of nonrubber footwear in April-June 1979--202.6 million pairs--was 4 percent greater than that in April-June 1978.

In the second quarter of 1979, imports of nonrubber footwear continued to account for more than 50 percent of the U.S. market. Second quarter 1979 imports of nonrubber footwear amounted to 102.7 million pairs, or 26 percent more than in the corresponding period of 1978. Second quarter 1979 imports from the controlled countries--Taiwan and Korea--showed a substantial increase of 30 percent over those in the corresponding period of last year as did second quarter 1979 imports from the uncontrolled countries which increased by 23 percent over the same period last year. Italy and Taiwan showed the largest gain from foreign suppliers in the second quarter of 1979.

The unemployment rate of domestic shoe workers was 8.5 percent in the second quarter of 1979 compared to 12.2 percent in the first quarter of this year and 8.0 percent in the second quarter of last year, representing an increase of 18 percent over the rate in the first half of last year. The Producers' Price Index for footwear rose to 216.0 in the second quarter of this year, compared with 181.2 a year ago.

The report is sent to the Special Representative for Trade Negotiations, who is responsible for monitoring the OMA's implemented by the Presidential proclamation.

Summary Highlights of Economic Conditions in the Nonrubber Footwear Industry in the Second Calendar Quarter of 1979

U.S. production.--Based on preliminary data, domestic production of nonrubber footwear was 99.0 million pairs in April-June 1979, or 12 percent lower than that in the corresponding period of last year (table 1).

U.S. imports.--Nonrubber footwear imports amounted to 102.7 million pairs in April-June 1979, or 26 percent more than in the corresponding period of 1978 (table 5).

Ratio of imports to consumption.--In the second quarter of 1979, imports of nonrubber footwear accounted for 51 percent of the U.S. market compared with 43 percent in the same period in 1978. For the first half of 1979, imports share of the U.S. market was 51 percent compared with 46 percent during the same period in 1978.

Source of imports.--Imports from the controlled countries--Taiwan and the Republic of Korea--as well as from the uncontrolled countries increased substantially in April-June 1979 over imports in April-June 1978. Second quarter 1979 imports from Taiwan and Korea increased 30 percent to 34.8 million pairs from 26.7 million pairs in the second quarter of 1978. Imports from the uncontrolled countries increased from 55.0 million pairs during the second quarter of 1978 to 67.9 million pairs in the second quarter of 1979, or by 23 percent. The largest share of this increase was accounted for by Italy, whose shipments to the United States increased from 12.9 million pairs in the second quarter of 1978 to 25.9 million pairs in the corresponding period of 1979. During the same periods, Taiwan's footwear exports to the United States increased from 21.4 million pairs to 29.5 million pairs. The Philippines, El Salvador, Singapore, and Greece also showed substantial percentage gains during this period, but from relatively small base figures. U.S. footwear imports from Spain and Hong Kong declined during the period.

Overall, the uncontrolled countries increased their share of total U.S. imports of nonrubber footwear from 37 percent in April-June 1977 to 66 percent in April-June 1979 (table 5).

Prices.--The Producers' Price Index for footwear increased to 216.0 in April-June 1979 from 181.2 in the corresponding period of 1978. The Consumer Price Index for footwear increased from 163.0 in the second quarter of 1978 to 175.3 in the second quarter of 1979.

Employment and unemployment rate.--Preliminary May 1979 employment data show that there were 149,700 employees in the nonrubber footwear industry, a drop of 9,600 employees from the May 1978 level and 12,700 employees from the May 1977 level (table 2). The unemployment rate 1/ for the second quarter of 1979 was 8.5 percent, compared to the 12.2 percent rate in the first quarter of this year (table 3).










Nonrubber footwear: Average unit value 1/ per pair of U.S. imports for consumption, by quarters, 1977-1979





Nonrubber footwear: Average unit value 1/ of U.S. shipments, by quarters, 1977-1979





1/ quarterly, 1977-1979


