This record reflects actions taken since January 1, 2013, as well as technical rectifications. See the Preface for additional information. In addition, the general notes file is being reposted on August 19, 2013, to reflect the expiration of the GSP and ATPA/ATPDEA programs at the close of July 31, 2013; chapter 62 is being reposted to reflect the correction of the subheading number for one provision, subheading 6204.63.20; and chapter 98 is being reposted to reflect the expiration of ATPA/ATPDEA. Further, chapter 4 will be reposted on or about September 1, 2013, to reflect changes in the membership of the European Union with regard to TRQ quantities allowed for certain cheeses. Last, the deletion of Bangladesh from the list of designated GSP beneficiary developing countries is reflected as of August 31, 2013.
