CHANGE RECORD

This change record includes all substantive changes made since the January 1, 2013 printed edition, including some matters which appeared in files reposted during 2013 or in the on-line only Revision 1 to the 2013 edition (because there was no printed supplement). The change record does not reflect subheading-level staged reductions in special rates of duty under United States free trade agreements that become effective on January 1, 2014; the deletion from individual subheadings of the HTS of tariff treatment under the Andean Trade Preference Act or the Andean Trade Promotion and Drug Eradication Act; the subheading-level impact of the expiration of the Generalized System of Preferences on July 31, 2013; or minor format corrections. Changes to the statistical annexes are likewise not listed. The abbreviation “PP” refers to “Presidential Proclamation.” Chapters 7, 22, 84, and 99 are being reposted on January 2.
