**NOTICE OF COMMISSION DECISION NOT TO REVIEW AN INITIAL  
DETERMINATION AMENDING THE NOTICE OF INVESTIGATION AND  
GRANTING A MOTION FOR TERMINATION OF RESPONDENT TELEX  
COMMUNICATIONS, INC. BASED UPON A PROPOSED CONSENT ORDER AND  
CONSENT ORDER STIPULATION; ISSUANCE OF CONSENT ORDER**

**AGENCY:** U.S. International Trade Commission.

**ACTION:** Notice.

**SUMMARY:** Notice is hereby given that the U.S. International Trade Commission has determined not to review an initial determination (“ID”) (Order No. 21) issued by the presiding administrative law judge (“ALJ”) in the above-captioned investigation amending the notice of investigation and granting a joint motion filed by complainant L-3 Communications Mobile-Vision, Inc. (“Mobile-Vision”) and respondent Telex Communications, Inc. (“Telex”) to terminate the investigation as to Telex based upon a proposed consent order and consent order stipulation. The Commission has issued the subject consent order.

**SUPPLEMENTARY INFORMATION:** This investigation was instituted on August 26, 2008, based on a complaint filed by Mobile-Vision of Boonton, New York. The complaint alleged violations of section 337 of the Tariff Act of 1930 (19 U.S.C. § 1337) in the importation into the United States, the sale for importation, and the sale within the United States after importation of certain base stations and wireless microphones that infringe certain claims of U.S. Patent No. 7,119,832. The complaint named 11 respondents, including Telex.

On February 18, 2009, the ALJ issued the subject ID, granting a joint motion for termination based upon a proposed consent order and consent order stipulation. The ALJ found that the consent order stipulation met the requirements of Commission Rule 210.21(c)(3), which governs consent order stipulations, and found that termination with respect to Telex is not contrary to the public interest. The ALJ also determined to amend the notice of investigation to reflect Telex's merge with, and name-change to, Bosch Security Systems, Inc. No petitions for review were filed.

The Commission has determined (1) not to review the subject ID and (2) to issue the subject consent order.

The authority for the Commission's determination is contained in section 337 of the Tariff Act of 1930, as amended (19 U.S.C. § 1337), and in sections 210.42 of the Commission's Rules of Practice and Procedure (19 C.F.R. § 210.42).
