**NOTICE OF COMMISSION DETERMINATION NOT TO REVIEW AN INITIAL
DETERMINATION GRANTING CERTAIN RESPONDENTS' MOTION FOR
SUMMARY DETERMINATION OF NO VIOLATION OF SECTION 337 AS TO
CERTAIN PRODUCTS**

AGENCY: U.S. International Trade Commission.

ACTION: Notice.

SUMMARY: Notice is hereby given that the U.S. International Trade Commission (the "Commission") has determined not to review a February 27, 2017, initial determination (the "ID") (Order No. 69) granting certain respondents' motion for summary determination of no violation of section 337 as to certain rental products in this investigation.

SUPPLEMENTARY INFORMATION: The Commission instituted this investigation on June 24, 2016, based on a complaint filed by Tessera Technologies, Inc.; Tessera, Inc.; and Invensas Corporation (collectively, "Tessera"). 81 FR 41344. The notice of investigation named several respondents, including Comcast Cable Communications, LLC; Comcast Cable Communications Management, LLC; and Comcast Business Communications, LLC (collectively, "Comcast"). The complaint alleged violations of section 337 of the Tariff Act of 1930, as amended, 19 U.S.C. 1337 ("section 337"), in the importation into the United States, the sale for importation, and the

sale within the United States after importation of certain semiconductor devices, semiconductor device packages, and products containing same by reason of infringement of one or more of U.S. Patent Nos. 6,856,007; 6,849,946; and 6,133,136. The Office of Unfair Import Investigations is not a party to this investigation.

On February 27, 2017, the ALJ issued the subject ID, which grants Comcast's motion for summary determination of no violation of section 337 as to certain of Comcast's rental products. On March 7, 2017, Tessera filed a petition seeking review of the subject ID. On March 14, 2017, Comcast filed a response to that petition.

The Commission has determined not to review the subject ID. Commissioner Kieff has provided concurring additional views.

Tessera's March 7, 2017, petition included a request that the Commission set a shortened deadline of March 14, 2017 for Comcast's response to Tessera's petition. Since Comcast filed its response on March 14, 2017, Tessera's request is moot. On March 17, 2017, Tessera filed a motion requesting leave to file a reply to Comcast's response to that petition. The Commission has determined to deny that motion.

The authority for the Commission's determination is contained in section 337 of the Tariff Act of 1930, as amended (19 U.S.C. 1337), and in part 210 of the Commission's Rules of Practice and Procedure (19 CFR part 210).
