**NOTICE OF COMMISSION DETERMINATION NOT TO REVIEW AN INITIAL
DETERMINATION EXTENDING THE TARGET DATE**

SUMMARY: Notice is hereby given that the U.S. International Trade Commission has determined not to review the presiding administrative law judge's ("ALJ") initial determination ("ID") (Order No. 25) extending the target date for completion of the investigation to March 14, 2018.

SUPPLEMENTARY INFORMATION: The Commission instituted this investigation on October 7, 2016, based on a complaint filed by Netlist, Inc. of Irvine, California. 81 FR 69853 (Oct. 7, 2016). The complaint, as supplemented, alleges violations of section 337 of the Tariff Act of 1930, as amended, 19 U.S.C. § 1337, in the importation into the United States, the sale for importation, and the sale within the United States after importation of certain memory modules and components thereof, and products containing the same by reason of infringement of certain claims of U.S. Patent Nos. 8,756,364; 8,516,185; 8,001,434; 8,359,501; 8,689,064; and 8,489,837. The complaint further alleges that an industry in the United States exists as required by 19 U.S.C. § 1337(a)(2). The notice of investigation named as respondents: SK hynix Inc. of Gyeonggi-do, Republic of Korea; SK hynix America Inc. of San Jose, California; and SK hynix memory

solutions Inc. of San Jose, California. The Office of Unfair Import Investigations is a party in this investigation.

On August 16, 2017, the ALJ issued the subject ID (Order No. 25), extending the target date by five weeks from February 7, 2018 to March 14, 2018. The subject ID indicates that the initial determination on violation will be due no later than November 14, 2017. No petition for review was filed.

The Commission has determined not to review the subject ID.

The authority for the Commission's determination is contained in section 337 of the Tariff Act of 1930, as amended, 19 U.S.C. § 1337, and in Part 210 of the Commission's Rules of Practice and Procedure, 19 C.F.R. Part 210.
