DETERMINATION TERMINATING THE INVESTIGATION AS TO  
U.S. PATENT NO. 9,099,972**

**SUMMARY:** Notice is hereby given that the U.S. International Trade Commission has determined not to review an initial determination (“ID”) (Order No. 40) of the presiding administrative law judge (“ALJ”), terminating the above-captioned investigation as to U.S. Patent No. 9,099,972 (“the ’972 patent”).

**SUPPLEMENTARY INFORMATION:** The Commission instituted this investigation on May 3, 2017, based on a complaint filed by Motorola Solutions, Inc. of Chicago, Illinois. 82 FR 20635-36. The complaint alleges violations of section 337 of the Tariff Act of 1930, as amended, 19 U.S.C. 1337, by reason of infringement of certain claims of the ’972 patent and the following U.S. Patent Nos.: 7,729,701; 8,116,284; 8,032,169; 6,591,111; 7,369,869; and 8,279,991. The complaint further alleges the existence of a domestic industry. The Commission’s notice of investigation named multiple respondents. The Office of Unfair Import Investigations is not participating in the investigation.

On January 27, 2018, complainant filed an unopposed motion to terminate the investigation with respect to allegations of infringement of the '972 patent.

The ALJ issued the subject ID on January 31, 2018, granting the motion for partial termination. She found that the motion for termination satisfied Commission Rule 210.21(a)(1) (19 CFR 210.21(a)(1)) and that no extraordinary circumstances exist that would prevent the requested partial termination. No party petitioned for review of the ID.

The Commission has determined not to review the ID.

The authority for the Commission's determination is contained in section 337 of the Tariff Act of 1930, as amended, 19 U.S.C. 1337, and in part 210 of the Commission's Rules of Practice and Procedure, 19 CFR part 210.
