**NOTICE OF COMMISSION DETERMINATION NOT TO REVIEW  
AN INITIAL DETERMINATION GRANTING AN UNOPPOSED MOTION FOR  
PARTIAL TERMINATION OF THE INVESTIGATION BASED ON THE  
WITHDRAWAL OF ALLEGATIONS AS TO A CERTAIN RESPONDENT,  
COMPLAINANT, AND PATENT**

**SUMMARY:** Notice is hereby given that the U.S. International Trade Commission has determined not to review an initial determination (Order No. 6) granting an unopposed motion for partial termination of the investigation based on the withdrawal of allegations as to respondent Majestic Mirrors & Frame, LLC, complainant Kelvin 42 LLC, and U.S. Patent No. 7,559,668.

**SUPPLEMENTARY INFORMATION:** The Commission instituted this investigation on May 8, 2017, based on a complaint filed by Electric Mirror, LLC of Everett, Washington and Kelvin 42 LLC of Pensacola, Florida ("Kelvin") (collectively, "Complainants"). 82 *Fed. Reg.* 21405 (May 8, 2017). The complaint, as amended, alleges violations of section 337 of the Tariff Act of 1930, as amended, 19 U.S.C. § 1337, in the importation into the United States, the sale for importation, and the sale within the United States after importation of certain mirrors with internal illumination and components thereof by reason of infringement of certain claims of U.S.

Patent No. 7,853,414 and U.S. Patent No. 7,559,668 (“the ’668 patent”). *Id.* The notice of investigation named as respondents Lumidesign Inc. of Ontario, Canada (“Lumidesign”); Majestic Mirrors & Frame, LLC of Miami, Florida (“Majestic”); and Project Light, LLC (d/b/a Project Light, Inc., Prospetto Light, LLC and/or Prospetto Lighting, LLC) of Stow, Ohio. *Id.* at 21405-06. The Office of Unfair Import Investigations was not named as a party to the investigation. *Id.* at 21406.

On June 2, 2017, Complainants filed a motion for partial termination of the investigation based on withdrawal of the allegations as to Majestic, Kelvin, and the ’668 patent. Majestic and Lumidesign did not oppose the motion. No other responses were received.

On June 19, 2017, the presiding administrative law judge (“ALJ”) issued an initial determination (“ID”), Order No. 6, granting the motion. The ALJ found no extraordinary circumstances that would prevent the requested partial termination of the investigation. The ALJ also found that Complainants complied with the requirements of Commission Rule 210.21(a). No petitions for review were filed.

The Commission has determined not to review the subject ID.

The authority for the Commission’s determination is contained in section 337 of the Tariff Act of 1930, as amended (19 U.S.C. § 1337), and in part 210 of the Commission’s Rules of Practice and Procedure (19 C.F.R. Part 210).
