SUPPLEMENTARY INFORMATION: The Commission instituted this investigation on July 5, 2019, based on a complaint filed by Ethicon LLC of Guaynabo, PR; Ethicon Endo-surgery, Inc. of Cincinnati, OH; and Ethicon US, LLC of Cincinnati, OH. 84 FR 32220 (July 5, 2019); *see also* 84 FR 65174 (Nov. 26, 2019) (amending the caption). The complaint alleged violations of section 337 of the Tariff Act of 1930, as amended, 19 U.S.C. 1337, based on the importation into the United States, the sale for importation, and the sale within the United States after importation of certain laparoscopic surgical staplers, reload cartridges, and components thereof by reason of infringement of one or more claims of U.S. Patent Nos. 9,844,379; 9,844,369; 7,490,749; 8,479,969; and 9,113,874. 84 FR at 32220. The Commission's notice of investigation named the following as respondents: Intuitive Surgical Inc. of Sunnyvale, CA; Intuitive Surgical Operations, Inc. of Sunnyvale, CA; Intuitive Surgical Holdings, LLC of Sunnyvale, CA; and Intuitive Surgical S. De R.L. De C.V. of Mexicali, Mexico. *Id.* The Office of Unfair Import Investigations is not participating in this investigation. *Id.*

On July 24, 2019, the presiding administrative law judge (“ALJ”) set the target date for completion of this investigation on December 7, 2020. Order No. 5, *unreviewed by Comm’n Notice* (Aug. 13, 2019). Subsequently, in light of the COVID-19 pandemic, the ALJ extended the target date twice more, first to February 8, 2021, Order No. 58, *unreviewed by Comm’n Notice* (Aug. 18, 2020), and then to October 8, 2021, *unreviewed by Comm’n Notice* (Oct. 20, 2020). On October 6, 2021, the Commission determined to extend the target date to the current date of October 13, 2021. Comm’n Notice (Oct. 6, 2021).

The Commission has determined to extend the target date for completion of this investigation to October 14, 2021.

The Commission vote for this determination took place on October 13, 2021.

The authority for the Commission’s determination is contained in section 337 of the Tariff Act of 1930, as amended (19 U.S.C. 1337), and in Part 210 of the Commission’s Rules of Practice and Procedure (19 CFR Part 210).
