**NOTICE OF A COMMISSION DETERMINATION NOT TO REVIEW AN INITIAL
DETERMINATION EXTENDING THE TARGET DATE FOR COMPLETION OF
THE INVESTIGATION**

AGENCY: U.S. International Trade Commission.

ACTION: Notice.

SUMMARY: Notice is hereby given that the U.S. International Trade Commission (“Commission”) has determined not to review an initial determination (“ID”) (Order No. 25) of the presiding chief administrative law judge (“CALJ”) extending the target date for completion of the investigation to January 9, 2023.

SUPPLEMENTARY INFORMATION: The Commission instituted this investigation under section 337 of the Tariff Act of 1930, as amended, 19 U.S.C. 1337, on May 19, 2021, based on a complaint filed by DISH DBS Corporation of Englewood, Colorado; DISH Technologies, L.L.C., of Englewood, Colorado; and Sling TV L.L.C., of Englewood, Colorado. 86 FR 27106-07 (May 19, 2021). The complaint alleged a violation of section 337 based upon the importation into the United States, the sale for importation, and the sale within the United States after importation of certain fitness devices, streaming components thereof, and systems containing same by reason of infringement of certain claims of U.S. Patent Nos. 9,407,564 (“the ’564 patent”); 10,757,156 (“the ’156 patent”); 10,469,554 (“the ’554 patent”); 10,469,555 (“the ’555 patent”); and 10,951,680 (“the ’680 patent”). The notice of investigation named as respondents

ICON Health & Fitness, Inc., FreeMotion Fitness, Inc., and NordicTrack Inc., all three of Logan, Utah; lululemon athletica inc., of Vancouver, Canada and Curiouser Products Inc. d/b/a MIRROR of New York, New York; and Peloton Interactive, Inc. of New York, New York. The Commission's Office of Unfair Import Investigations also was named as a party.

Respondent ICON Health & Fitness, Inc. was later renamed to "iFit Inc." Order No. 14 (Nov. 4, 2021), *unreviewed by* Notice (Dec. 6, 2021). Subsequently, the investigation was terminated in part as to claims 6, 11, and 12 of the '156 patent, claim 22 of the '554 patent, and claim 17 of the '555 patent; and claims 9 and 12 of the '156 patent, claim 19 of the '554 patent, claims 12 and 13 of the '555 patent, and claim 6 of the '564 patent are no longer asserted as to respondents iFit Inc.; Free Motion Fitness, Inc.; NordicTrack, Inc.; and Peloton Interactive, Inc. Order No. 15 (Nov. 19, 2021), *unreviewed by* Notice (Dec. 21, 2021). Likewise, the investigation was partially terminated with respect to claims 6-8, 10, and 13-15 of the '564 patent, claims 3 and 6-12 of the '156 patent, claims 18-19, 21-25, and 30 of the '554 patent, claims 12-13, 16-17, and 26-27 of the '555 patent, and all asserted claims of the '680 patent. Order No. 21 (Mar. 3, 2022), *unreviewed by* Notice (Mar. 22, 2022). Furthermore, the target date for completion of the investigation was extended to November 28, 2022, with the final ID on alleged violation of section 337 due on July 28, 2022. Order No. 23 (July 19, 2022), *unreviewed by* Notice (August 12, 2022). Subsequently, the target date for completion of the investigation was extended to December 12, 2022, with the final ID on alleged violation of section 337 due on August 12, 2022. Order No. 24 (July 28, 2022), *unreviewed by* Notice (August 29, 2022).


On August 12, 2022, the CALJ issued the subject ID extending the target date. The ID noted that on June 23, 2022, the investigation was reassigned to the CALJ. ID at 1. The ID found that in view of the recent reassignment, good cause exists to extend the target date for completion of this investigation by approximately four additional weeks. *Id.* The ID stated that the new target date for completion of this investigation is January 9, 2023, and the final initial determination on alleged violation of section 337 will therefore be due on September 9, 2022. *Id.*

No party petitioned for review of the ID. The Commission has determined not to review the subject ID. The target date is now January 9, 2023.

The Commission vote for this determination took place on September 13, 2022.

The authority for the Commission's determination is contained in section 337 of the Tariff Act of 1930, as amended (19 U.S.C. 1337), and in Part 210 of the Commission's Rules of Practice and Procedure (19 CFR Part 210).
