**NOTICE OF A COMMISSION DETERMINATION NOT TO REVIEW AN INITIAL
DETERMINATION TERMINATING THE INVESTIGATION AS TO RESPONDENTS
CALPHA AND LAB1ST BASED ON SETTLEMENT**

AGENCY: U.S. International Trade Commission.

ACTION: Notice.

SUMMARY: Notice is hereby given that the U.S. International Trade Commission (“Commission”) has determined not to review an initial determination (“ID”) (Order No. 18) of the presiding administrative law judge (“ALJ”), terminating the investigation as to respondents Calpha Industries, Inc. (“Calpha”) and Lab1st Scientific and Industrial Equipment, Inc. (“Lab1st”) based on settlement.

SUPPLEMENTARY INFORMATION: The Commission instituted this investigation on May 4, 2022. 87 FR 26372 (May 4, 2022). The complaint, as supplemented, alleged violations of section 337 of the Tariff Act of 1930, as amended, 19 U.S.C. 1337, in the importation into the United States, the sale for importation, or the sale within the United States after importation of certain centrifuge utility platform and falling film evaporator systems and components thereof by reason of infringement of claims 1, 10, and 14 of U.S. Patent No. 10,814,338; claims 1, 10, and 18 of U.S. Patent No. 11,014,098; and claims 1, 9, and 19 of U.S. Patent No. 10,899,728. *Id.* The complaint further alleged that a domestic industry exists. *Id.* The Commission’s notice of investigation named fifteen respondents, including Calpha of Laguna Hills, CA and Lab1st of

Shanghai, China. *Id.* at 26373. The Office of Unfair Import Investigations is also participating in the investigation. *Id.*

On June 30, 2022, complainant Apeks, LLC (“Apeks”) moved to terminate the investigation as to Calpha and Lab1st based on a settlement agreement. On July 15, 2022, the ALJ issued Order No. 18, the subject ID, granting Apeks’s motion. The ID finds that Apeks’s motion complies with the Commission’s rules and that there is no evidence that terminating this investigation based on the settlement agreement would be contrary to the public interest. No petitions for review of the ID were filed.

The Commission has determined not to review the subject ID.


Calpha and Lab1st are terminated from this investigation.

The Commission vote for this determination took place on August 4, 2022.

The authority for the Commission’s determination is contained in section 337 of the Tariff Act of 1930, as amended (19 U.S.C. 1337), and in Part 210 of the Commission’s Rules of Practice and Procedure (19 CFR Part 210).
