**NOTICE OF A COMMISSION DETERMINATION NOT TO REVIEW**  
**AN INITIAL DETERMINATION SETTING A 20.5-MONTH TARGET DATE**

**AGENCY:** U.S. International Trade Commission.

**ACTION:** Notice.

**SUMMARY:** Notice is hereby given that the U.S. International Trade Commission (“Commission”) has determined not to review an initial determination (“ID”) (Order No. 3) issued by the presiding administrative law judge (“ALJ”) setting a 20.5-month target date of May 29, 2024, for completion of the above-captioned investigation.

**SUPPLEMENTARY INFORMATION:** The Commission instituted this investigation on September 15, 2022, based on a complaint filed by Google LLC of Mountain View, California. 87 FR 56702-703 (Sept. 15, 2022). The complaint, as supplemented, alleges violations of section 337 of the Tariff Act of 1930, as amended, 19 U.S.C. 1337, in the importation into the United States, sale for importation, or sale in the United States after importation of certain audio players and components thereof by reason of infringement of certain claims of U.S. Patent Nos. 10,593,330; 10,134,398; and 7,7705,565. *Id.* The complaint further alleges that a domestic industry exists. *Id.* The Commission’s notice of investigation names Sonos, Inc. of Santa Barbara, California as the respondent. *Id.* at 56703. The Office of Unfair Import Investigations was not named as a party to this investigation. *Id.*

On September 16, 2022, the presiding ALJ issued the subject ID pursuant to Commission Rule 210.51 (19 CFR 210.51), setting a 20.5-month target date of May 29, 2024. Order No. 3 (Sept. 16, 2022).

No party filed a petition for review of the subject ID.

The Commission has determined not to review the subject ID. Accordingly, the target date for completion of this investigation is May 29, 2024.

The Commission vote for this determination took place on October 17, 2022.

The authority for the Commission's determination is contained in section 337 of the Tariff Act of 1930, as amended (19 U.S.C. 1337), and in Part 210 of the Commission's Rules of Practice and Procedure (19 CFR Part 210).
