**NOTICE OF COMMISSION DETERMINATION NOT TO REVIEW AN INITIAL  
DETERMINATION TERMINATING THE INVESTIGATION WITH RESPECT TO  
CERTAIN PATENT CLAIMS**

**AGENCY:** U.S. International Trade Commission.

**ACTION:** Notice.

**SUMMARY:** Notice is hereby given that the U.S. International Trade Commission has determined not to review an initial determination (“ID”) (Order No. 25) issued by the presiding administrative law judge (“ALJ”), terminating the investigation with respect to certain patent claims based on the complainant’s partial withdrawal of the complaint.

**SUPPLEMENTARY INFORMATION:** The Commission instituted this investigation on May 8, 2023, based on a complaint filed by Netgear Inc. of San Jose, California (“Netgear”). 88 FR 29693-94 (May 8, 2023). The complaint alleges violations of section 337 of the Tariff Act of 1930, as amended, 19 U.S.C. 1337, in the importation into the United States, the sale for importation, or the sale within the United States after importation of certain Wi-Fi routers, Wi-Fi devices, mesh Wi-Fi network devices, and hardware and software components thereof by reason of infringement of certain claims of U.S. Patent Nos. 7,936,714 (“the ’714 patent”); 10,681,698 (“the ’698 patent”); 10,278,179 (“the ’179 patent”); 9,468,025 (“the ’025 patent”); 10,327,242 (“the ’242 patent”); and 10,356,681 (“the ’681 patent”). *Id.* The complaint further alleges that a domestic industry exists. *Id.* The Commission’s notice of investigation named as respondents

TP-Link Technologies Co., Ltd. of Shenzhen China; TP-Link Corporation Limited, f/k/a TP-Link International Limited of Kowloon, Hong Kong; TP-Link USA Corporation of Irvine, California; and TP-Link Research Institute USA Corp. d/b/a TP-Link Research America Corp. of San Jose, California. *Id.* at 20552. The Office of Unfair Import Investigations is not participating in the investigation. *Id.*

On November 8, 2023, Netgear filed an unopposed motion to terminate the investigation based on its withdrawal of the complaint with respect to claims 1-5, 14-17, and 31 of the '714 patent; claims 2-7, 9, 10, 13, and 14 of the '698 patent; claims 2-6, 8-10, 18, and 19 of the '179 patent; claims 2, 6, 8, 13, 14, and 16-21 of the '025 patent; and claims 2, 3, 6, 8, 14-17, 23, 24, 27, 29, and 35-37 of the '242 patent. The motion indicates that Netgear continues to assert claims 13 and 32 of the '714 Patent; claims 1, 8, 11, 12, and 15-22 of the '698 Patent; claims 1, 7, and 11-17 of the '179 Patent; claims 1, 3-5, 7, 10, 11, and 15 of the '025 Patent; claims 1, 4, 7, 9, 18, 19, 22, 25, 28, and 30 of the '242 Patent; and claims 3, 4, 10, and 11 of the '681 Patent. No party filed a response to the motion.

On November 9, 2023, the ALJ issued the subject ID pursuant to Commission Rule 210.21(a) (19 CFR 210.21(a)), granting the motion and terminating the investigation with respect to the withdrawn claims. No party petitioned for review of the subject ID.

The Commission has determined not to review the subject ID. Claims 1-5, 14-17, and 31 of the '714 patent; claims 2-7, 9, 10, 13, and 14 of the '698 patent; claims 2-6, 8-10, 18, and 19 of the '179 patent; claims 2, 6, 8, 13, 14, and 16-21 of the '025 patent; and claims 2, 3, 6, 8, 14-17, 23, 24, 27, 29, and 35-37 of the '242 patent are hereby terminated from this investigation.

The Commission vote for this determination took place on December 11, 2023.

The authority for the Commission's determination is contained in section 337 of the Tariff Act of 1930, as amended (19 U.S.C. 1337), and in Part 210 of the Commission's Rules of Practice and Procedure (19 CFR Part 210).
