**NOTICE OF A COMMISSION DETERMINATION NOT TO REVIEW
AN INITIAL DETERMINATION TERMINATING THE INVESTIGATION
WITH RESPECT TO A RESPONDENT BASED ON CONSENT ORDER AND
CONSENT ORDER STIPULATION; ISSUANCE OF CONSENT ORDER**

AGENCY: U.S. International Trade Commission.

ACTION: Notice.

SUMMARY: Notice is hereby given that the U.S. International Trade Commission (“Commission”) has determined not to review an initial determination (“ID”) (Order No. 7) issued by the presiding administrative law judge (“ALJ”) terminating the above-captioned investigation as to Respondent SZY Holdings (“SZY”) and to issue a consent order.

SUPPLEMENTARY INFORMATION: The Commission instituted this investigation on May 31, 2023, based on a complaint, as supplemented, filed by Composite Resources, Inc. of Rock Hill, South Carolina and North American Rescue, LLC of Greer, South Carolina (collectively, “Complainants”). 88 FR 34893-95 (May 31, 2023). The complaint, as supplemented, alleges violations of section 337 of the Tariff Act of 1930, as amended, 19 U.S.C. 1337, in the importation into the United States, sale for importation, or sale in the United States after importation of certain blood flow restriction devices with rotatable windlasses and components thereof that infringe one or more of: claims 1-17 of U.S. Patent No. 7,842,067, claims 1-30 of U.S. Patent No. 8,888,807, and claims 1-13 of U.S. Patent No. 10,016,203; United States Trademark Registration Nos. 3,863,064 and 5,149,328; and the elements of Complainants’ allegedly distinctive common law trade dress in violation of Section 43(a) of the Lanham Act (15 U.S.C. 1125). *Id.* at 34893-94; *see* Complaint, ¶¶ 9-15. The Commission’s notice of investigation names thirty respondents including SZY Holdings LLC (“SZY”) of Brooklyn, New

York. *Id.* at 34894. The Office of Unfair Import Investigations (“OUII”) is also a party to this investigation. *Id.*

On July 26, 2023, Complainants and SZY jointly moved to terminate the investigation as to SZY based on a consent order and consent order stipulation. On July 31, 2023, OUII filed a response in support of the joint motion to terminate.

On August 9, 2023, the presiding ALJ issued the subject ID granting the joint motion to terminate. The ALJ found that the consent order stipulation complied with the requirements of 19 CFR 210.21(c)(3) and the proposed consent order complied with the requirements of 19 CFR 210.21(c)(4). *Id.* at 2. The ALJ further found no public interest concerns weighing against termination of the investigation as to SZY. *Id.* at 2-3.

No party filed a petition for review of the subject ID.

The Commission has determined not to review the subject ID and to issue a consent order with respect to SZY. The investigation is hereby terminated with respect to SZY.

The Commission vote for this determination took place on September 5, 2023.

The authority for the Commission’s determination is contained in section 337 of the Tariff Act of 1930, as amended (19 U.S.C. 1337), and in Part 210 of the Commission’s Rules of Practice and Procedure (19 CFR Part 210).
