**NOTICE OF COMMISSION DETERMINATION NOT TO REVIEW AN INITIAL
DETERMINATION GRANTING AN UNOPPOSED MOTION TO TERMINATE THE
INVESTIGATION AS TO RESPONDENT VIZIO, INC. BASED UPON SETTLEMENT**

ACTION: Notice.

SUMMARY: Notice is hereby given that the U.S. International Trade Commission has determined not to review the presiding administrative law judge's ("ALJ") initial determination ("ID") (Order No. 75) granting an unopposed motion to terminate the investigation as to respondent Vizio, Inc. of Irvine, California ("Vizio") based upon settlement.

SUPPLEMENTARY INFORMATION: The Commission instituted this investigation on June 25, 2013, based on a complaint filed by Graphics Properties Holdings, Inc. of New Rochelle, New York ("GPH"). 78 *Fed. Reg.* 38073 (June 25, 2013). The complaint alleged violations of section 337 of the Tariff Act of 1930, as amended, 19 U.S.C. § 1337, in the importation into the United States, the sale for importation, and the sale within the United States after importation of certain consumer electronics with display and processing capabilities by reason of infringement of certain claims of United States Patent Nos. 6,650,327; 8,144,158; and 5,717,881, which has been terminated from the investigation. The notice of investigation named several entities as respondents, including Vizio.

On March 25, 2014, GPH and Vizio filed an unopposed motion to terminate the investigation as to Vizio based upon settlement. That same day, the Commission investigative attorney filed a response in support of the motion. No other responses to the motion were filed.

On April 4, 2014, the ALJ issued the subject ID, granting the motion. The ALJ found that the settlement agreement complies with the requirements of Commission Rule 210.21(b) (19 C.F.R. § 210.21(b)) and that terminating Vizio from the investigation would not be contrary to the public interest. None of the parties petitioned for review of the ID.

The Commission has determined not to review the ID.

The authority for the Commission's determination is contained in section 337 of the Tariff Act of 1930, as amended (19 U.S.C. § 1337), and in Part 210 of the Commission's Rules of Practice and Procedure (19 C.F.R. Part 210).
